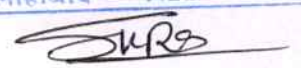

Therefore, a **Demand Notice dated 26.09.2024** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / Guarantor(s) **Late Malay Maji alias Moloy Maji** (since deceased on 09.05.2024) Represented by his legal heirs Sri Swapn Majhi, f/o Late Malay Majhi and others), **Sri Swapn Maji**, liable to the Bank to pay the amount due to the tune of **Rs. 3,25,778.00 (Rupees Three Lakhs Twenty five Thousand Seven Hundred and Seventy eight only)** as on 26.09.2024 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 26.09.2024.

As **Late Malay Maji alias Moloy Maji** (since deceased on 09.05.2024) Represented by his legal heir's Sri Swapn Majhi, f/o Late Malay Majhi, **Sri Swapn Maji**, failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 13.12.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6(2) & 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 28.07.2026 is of **Rs. 3,87,974 /- (Rupees Three lacs Eighty Seven thousand Nine Hundred Seventy Four only)** with further interest, costs, other charges and expenses thereon from 29.07.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 25.09.2026 Time 11:00 AM which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 10.09.2026 to 23.09.2026 between **10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

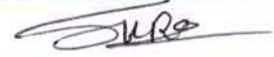
