Therefore, a Demand Notice dated 25.03.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / Guarantor(s) **M/s Ghosh Telecom , M/s Ghosh Shoe House ,Mr. Asit Ghosh, Mrs. Namita Ghosh** liable to the Bank to pay the amount due to the tune of **Rs.21,69,161.00 (Rupees Twenty One Lakhs Sixty Nine Thousand One Hundred and Sixty One only)** as on 25.03.2025 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 25.03.2025.

As **M/s Ghosh Telecom , M/s Ghosh Shoe House ,Mr. Asit Ghosh, Mrs. Namita Ghosh** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 22.07.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. *As per Rule 6(2) & 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 27.07.2026 is of **Rs. 23,47,355 /-** (Rupees Twenty three lacs Forty seven thousand Three hundred Fifty five only) with further interest, costs, other charges and expenses thereon from 28.07.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

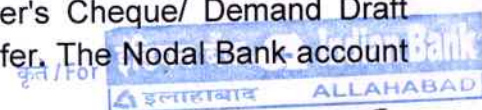

The intending Bidders/ Purchasers are requested to register with online portal (<https://www.baanknet.com>) (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their e KYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 07.09.2026 i.e. before the e-Auction time in the portal.
