Ms.Beefathima , Ms.Ayisha , and Mr.Zainuddin have availed **Home loan** facility from Indian Bank, **Kasargod** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. Ms.Beefathima , Ms.Ayisha , and Mr.Zainuddin failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **05.02.2024** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Ms.Beefathima , Ms.Ayisha , and Mr.Zainuddin liable to the Bank to pay the amount due to the tune of **Rs.10,51,229/- (Rupees Ten lakhs fifty one thousand two hundred twenty nine Only)** as on **05.02.2024** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **05.02.2024**

As Ms.Beefathima , Ms.Ayisha , and Mr.Zainuddin failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **07.05.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

The amount due as on 17.08.2026 is **11,18,741/-(Rupees Eleven lakhs eighteen thousand seven hundred forty-one only)** with further interest, costs, other charges and expenses thereon from **18.08.2026.**

*As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
