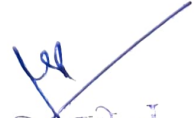

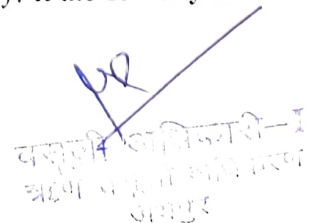
1. The reserve price below which the property shall not be sold is **Rs. 27,00,000/- (Rupees Twenty Seven Lakh only)**
