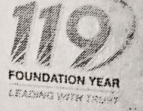

Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on 12-07-2023 calling upon the Borrower(s)/Guarantor(s)/Corporate Guarantor(s) of **Mrs. NEHA SAUDHGAR D O RAIES SAUDHGAR and Guarantor-JULEKHA BEGAM W/O MOHAMMAD RAHEES.
