M/s Shri Sidha Vinayak Pindi Enterprises Through Proprietor Mrs. Giraja Tripathi (Borrower) 2. Mrs. Giraja Tripathi Proprietor Shri Sidha Vinayak Pindi Enterprises (Borrower & Guarantor) 3. Smt Chandrawati Tiwari W/o Late Shri Krishan Kumar Tiwari (Guarantor & Mortgager) liable to the Bank to pay the amount due to the tune of ₹1339655.00 (Rupees Thirteen lakhs thirty nine thousand six hundred fifty five only) as on 03/04/2025

with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 17/09/2025.

As M/s Shri Sidha Vinayak Pindi Enterprises Through Proprietor Mrs. Giraja Tripathi (Borrower) failed to make payment despite Demand Notice, the Authorized Officer took Constructive /Symbolic/ Physical possession of the schedule mentioned properties under the Act on 03/12/2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
