Notice of sale under Rule 9(1) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

M/s. Provident Engineering, Represented by its Proprietrix : Mrs. S. Rajini availed loan facilities from Indian Bank, Mogappair Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Provident Engineering, Represented by its Proprietrix : Mrs. S. Rajini failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 27.07.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling M/s. Provident Engineering, Represented by its Proprietrix : Mrs. S. Rajini and another liable to the Bank to pay the total amount due to the tune of **Rs.33,52,225.56 (Rupees Thirty three lakhs fifty two thousand two hundred twenty five and paise fifty six only) as on 30.04.2022** with further interest, costs, other charges and expenses. Both failed to make payment despite Demand Notice dated 27.07.2022.

As M/s. Provident Engineering, Represented by its Proprietrix : Mrs. S. Rajini failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 29.10.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER/AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The total amount due as on 18.08.2026 is **Rs.67,64,326/- (Rupees Sixty seven lakhs sixty four thousand three hundred and twenty six only)** with further interest, costs, other charges and expenses thereon from 19.08.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 07.09.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **02.09.2026 to 03.09.2026 between 10.00 am and 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the

Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://www.baanknet.com>) **for depositing in bidders e-Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**.
