- e. The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs. 2,34,000/- (Rupees Two Lac Thirty Four Thousand Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **28/09/2026 at 5:00 PM.**
