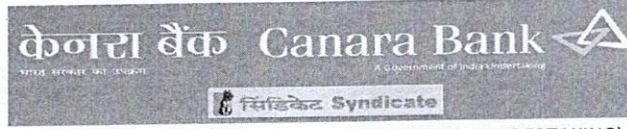

Reserve price) on closure of 'Online' auction shall be declared as successful bidder.
