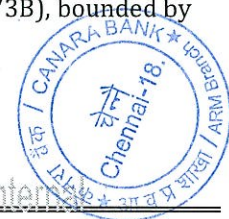

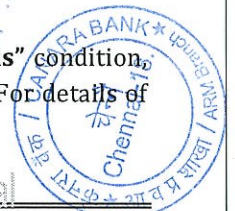

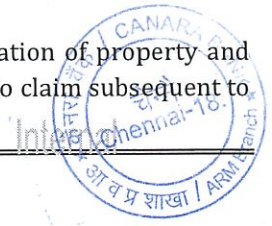

- b. The property/ies will be sold above the reserve price.
 - c. The property can be inspected, with Prior Appointment with Authorised Officer, on **07.09.2026** between 11.00 A.M. & 4.00 P.M.
 - d. 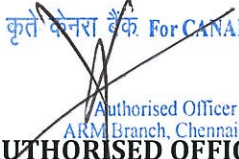
