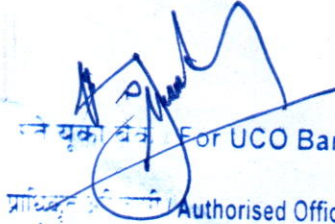

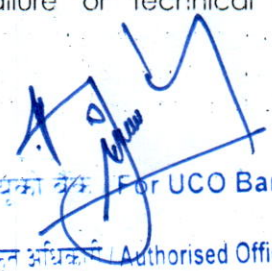

OTHER TERMS AND CONDITIONS OF E-AUCTION SALE

The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions.

1. The auction sale will be "online through e-auction" portal <https://ebkgray.in/> or <https://BAANKNET.com/eauction-psb/x-login>
2. The intending Bidders/ Purchasers are requested to register on portal (<https://ebkgray.in/> or <https://BAANKNET.com>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents.
