PROCLAMATION OF SALE

Whereas under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, a notice dated 22.05.2026 for the recovery of sum of Rs.28,39,12,810.22 (Rupees Twenty-Eight Crore Thirty-Nine Lakh Twelve Thousand Eight Hundred Ten and Paise Twenty-Two Only) plus further interest and charges on other loans from the date of NPA, was issued to the SHIV SHAKTI AGRO PRODUCTS (Borrower), M/s SHIV SHAKTI AGRO PRODUCTS, SANGITA BANSAL (Partner), RAJANI AGARWAL (Partner) & AJAY KUMAR BANSAL (Guarantor) and whereas the secured assets mentioned in the schedule were taken in symbolic possession on 11.08.2026 Whereas the sale of secured asset is to be made to recover the secured debt. And whereas on the 28.09.2026 (the date fixed for the sale), there will be due under the secured debt, a sum of Rs.28,39,12,810.22 (Rupees Twenty-Eight Crore Thirty-Nine Lakh Twelve Thousand Eight Hundred Ten and Paise Twenty-Two Only) plus further costs and interest plus charge. Notice is hereby given that, in the absence of any postponement/discontinuance of the sale, the said property shall be sold by public auction at 11:00AM on the said the 28.09.2026 at ASANSOL & KULTI of the property of the borrower above named and the liabilities and claims attaching to the said property, so far as they have been ascertained, are those specified in the Schedule against each lot. The property will be put up for sale in the lots specified in the Schedule. If the amount to be realized by sale is satisfied by the sale of a portion of the property, the sale shall be immediately stopped with respect to the remainder. The sale will also be stopped if, before any lot is knocked down, amount due as aforesaid, interest and cost (including the cost of the sale) are tendered to the 'Authorized Officer' or proof is given to his satisfaction that the amount of such secured debt, interest and costs has been paid. In the event of any dispute arising as to the amount bid, or as to the bidder, the lot shall at once be again put up to auction. The highest bidder shall be declared to be the purchaser of any lot provided always that he is legally qualified to bid and provided further that the amount bid by him is not less than the reserve price. It shall be in the discretion of the 'Authorized Officer' to decline acceptance of the highest bid when the price offered appears so clearly inadequate as to make it inadvisable to do so.
