M/S L U Steel (Partners Luthfur Rahman & Uttam Paul) had availed Cash Credit Loan facility from Indian Bank, Karimganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/S L U Steel failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 12.05.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) 1. M/S. L U Steel (Partners Luthfur Rahman and Uttam Paul) 2. Luthfur Rahman (Partner) 3. Uttam Paul (Partner) 4. Tripti Paul (Guarantor Cum Mortgagor), liable to the Bank to pay the amount due to the tune of Rs. 6090717.00 (Rupees Sixty Lakh Ninety Thousand Seven Hundred Seventeen only) as on 11.05.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 12.05.2026.

As M/S L U Steel failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 22.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 11.05.2026 amounts to of Rs. 6090717.00 (Rupees Sixty Lakh Ninety Thousand Seven Hundred Seventeen only) with further interest, costs, other charges and expenses thereon.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 30.09.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The Tender/bid Form with the Terms and conditions can be had on-line from the website (<https://baanknet.com>) and using the provision in the system/software. The tender form and the terms and conditions would be available in the website from **01.09.2026 to 29.09.2026**.

Further, they are requested to upload requisite KYC documents. 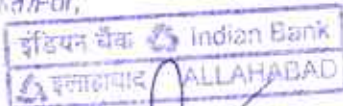
