Smt. Rakhi Das, W/o Subhrajit Das and Shri Subhrajit Das, S/o Late Indrajit Das availed Home Loan facility from Indian Bank, A J C Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt. Rakhi Das, W/o Subhrajit Das and Shri Subhrajit Das, S/o Late Indrajit Das failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 19.12.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s), Smt. Rakhi Das, W/o Subhrajit Das (Borrower / Mortgagor/ Guarantor) and Shri Subhrajit Das, S/o Late Indrajit Das (Borrower / Mortgagor/ Guarantor) liable to the Bank to pay the amount due to the tune of **Rs. 28,36,690.00 (Rupees Twenty-Eight Lakh Thirty-Six Thousand Six Hundred Ninety Only)** as on 18.12.2025 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 19.12.2025.

As Smt. Rakhi Das, W/o Subhrajit Das and Shri Subhrajit Das, S/o Late Indrajit Das failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
