Whereas Mr. DV Subramanyam has borrowed monies from Indian Overseas Bank against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on **03.04.2018** calling upon **the borrowers, Mortgagor & Guarantor Mr. DV Subramanyam, Mr. D Sathyanarayana, Mr. D Sambasiva and Mr. D V Shankar Kumar** to pay the amount due to the Bank, being **Rs.1,18,82,943.24/- (Rupees One Crore Eighteen Lakh Eighty Two Thousand Nine Hundred Forty Three and paise Twenty Four Only)** in account of **Mr. DV Subramanyam** and **Rs.1,28,27,874/- (Rupees One Crore Twenty Eight Lakh Twenty Seven Thousand Eight Hundred Seventy Four Only)** in account of **Mr. D Sathyanarayana, Mr. D Sambasiva & Mr. DV Shankar Kumar** and **Rs 28,77,964.03/- (Rupees Twenty Eight Lakh Seventy Seven Thousand Nine Hundred Sixty Four & paise Three Only)** in account of **M/s DeeCee Hospitalities** as on **31.03.2018** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **29.01.2026 & 31.01.2026** under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.95,29,378/- (Rupees Ninety-Five lakhs Twenty Nine Thousand Three Hundred Seventy Eight Only)** in account of **Mr. DV Subramanyam**, **Rs 2,39,09,002/- (Rupees Two Crore Thirty-Nine Lakhs Nine Thousand & Two only)** in account of **Mr. DV Subramanyam** and **Rs 3,56,90,708/- (Rupees Three Crore Fifty-Six Lakhs Ninety Thousand Seven Hundred and Eight only)** in account of **Mr. D Sathyanarayana, Mr. D Sambasiva and Mr. D V Shankar Kumar** and **Rs 34,96,356/- (Rupees Thirty Four Lakh Ninety Six Thousand Three Hundred Fifty Six Only)** in account of **M/s DeeCee Hospitalities** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

Terms and Conditions

1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com> under the supervision of the of the Authorized Officer of the Bank.

2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **07.09.2026 before 10.30 AM**. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through Net Banking/UPI/NEFT/RTGS/Challan Mode **(in challan mode, after generation of Challan from <https://baanknet.com> which will provide account details, bidder to send NEFT/RTGS)** in bidders EMD Wallet account.
