Mr. Naresh Singh Rajpurohit & Mrs. Savita Naresh Rajpurohit availed Housing Loan facility from Indian Bank, Dadar East Branch, Mumbai the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Naresh Singh Rajpurohit & Mrs. Savita Naresh Rajpurohit failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 10.12.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Mortgagor(s), Guarantor(s) Mr. Naresh Singh Rajpurohit & Mrs. Savita Naresh Rajpurohit liable to the Bank to pay the amount due to the tune of Rs. 33,59,525.56/- (Rupees Thirty-Three Lacs Fifty Nine Thousand Five Hundred Twenty Five and Fifty Six Paise only) as on dated 09.12.2025 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 10.12.2025.

As Mr. Naresh Singh Rajpurohit & Mrs. Savita Naresh Rajpurohit failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule



mentioned properties under the Act on 11.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 09.12.2025 is Rs. 33,59,525.56/-(Rupees Thirty-Three Lacs Fifty Nine Thousand Five Hundred Twenty Five and Fifty Six Paise only) with further interest, costs, other charges and expenses thereon from 10.12.2025.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 07.09.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense on 01.09.2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 07.09.2026 i.e the e-Auction Date and before the e-auction end time in the portal. The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefore.
