E-Auction Sale Notice for sale of Immovable Assets under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 read with proviso to Rule 8 (6) of the Security Interest (Enforcement) Rules, 2002

Whereas **Ms. Kirti Sharma** has borrowed monies from **Indian Overseas Bank, Thane Branch** against the mortgage of the immovable properties more fully described in the schedule hereunder and upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 on **08.12.2025** calling upon **the borrowers Ms. Kirti Sharma and the guarantor Mr Dadaso Sanjay Bhale** to pay the amount due to the Bank, being **Rs. 77,26,390.38 (Rupees Seventy-Seven Lakhs Twenty-Six Thousand Three Hundred and Ninety Paise Thirty-Eight Only)** as on **07.12.2025** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrower having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken **Possession** of the secured assets more fully described in the schedule hereunder on **18.04.2026** under Section 13 (4) of the Act with the right to sell the same in "**As is where is**", "**As is what is**" and "**Whatever there is**" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking symbolic possession was intimated as an amount of **Rs. 79,23,627.05 (Rupees Seventy-Nine Lakhs Twenty-Three Thousand Six Hundred and Twenty-Seven and Paise Five Only)** as on **16.04.2026** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **31.07.2026** work out to **Rs. 80,04,771.38 (Rupees Eighty Lakhs Four Thousand Seven Hundred Seventy-One and Paise Thirty-Eight Only)** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, amounting to **₹33197/-**, in her Housing Loan Account, subsequent to the Bank issuing demand notice.
