Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on **10.01.2019** calling upon the Borrower(s)- **Mrs. Preeti Singh W/O Brijendra Singh Dangi** and Guarantor(s)/Corporate Guarantor(s) of **Mrs. Savitri Singh W/O Prahalad Singh** to repay the amount in terms of the said notice within 60 days from the date of the said notice.
