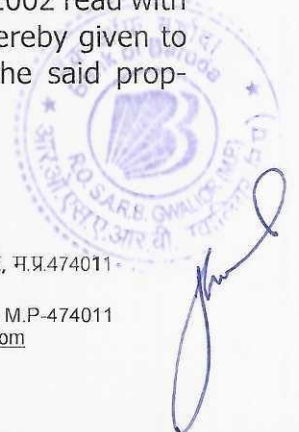
Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on **19.09.2022** calling upon the Borrower(s)- **Mr. Vijay Shivhare S/O Ramlakhan Shivhare (Borrower) and Guarantor(s)** to repay the amount in terms of the said notice within 60 days from the date of the said notice.

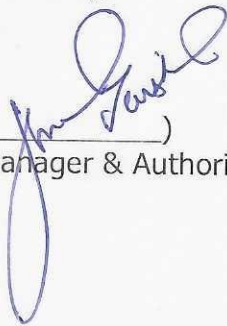
