(b) The intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with PSB Alliance Pvt Limited at https://baanknet.com/ by means of NEFT/RTGS transfer from his bank account. (c) The intending bidders should take care that the EMD is transferred at least one day
