Sale of Immovable Property Mortgaged to the Bank under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002

Whereas **Mr. Vishal Rajbhar, Mr. Kalicharan Rajbhar & Mrs. Rajmata Devi with address**, Flat No. 203, 2nd Floor, A-Wing, Keshav Kunj, Om Shree Keshav Kunj C.H.S. Ltd., Village – Alyali, Palghar, Maharashtra - 401404 and Permanent address at #45, BRAHMANPURA, BABHANPURA UTTAR, MAU, UTTAR PRADESH – 276 129 has borrowed monies from Indian Overseas Bank against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on **16.04.2025** calling upon the borrowers **Mr. Vishal Rajbhar, Mr. Kalicharan Rajbhar & Mrs. Rajmata Devi with address**, Flat No. 203, 2nd Floor, A-Wing, Keshav Kunj, Om Shree Keshav Kunj C.H.S. Ltd., Village – Alyali, Palghar, Maharashtra - 401404 and Permanent address at #45, BRAHMANPURA, BABHANPURA UTTAR, MAU, UTTAR PRADESH – 276 129 to pay the amount due to the Bank, being **Rs.2061348.68 (Rupees Twenty Lakh Sixty One Thousand Three Hundred Forty Eight and Paisa sixty eight only)** as on 16-04-2025 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken Physical possession of the secured assets more fully described in the schedule hereunder on **24.07.2026** under Section 13 (4) of the Act with the right to sell the same in "**As is where is**", "**As is what is**" and "**Whatever there is**" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of possession notice was intimated as **Rs.23,39,862 (Rupees Twenty Three Lakh Thirty Nine Thousand Eight Hundred and Sixty Two only) as on 15.07.2025** payable together with further interest at contractual rates and rests along with costs, charges etc., till date of repayment, after reckoning repayments, if any, since the date mentioned in the possession notice.

The dues of the borrower as on **13.08.2026** works out to **Rs. 23,61,805 (Rupees Twenty Three Lakh Sixty One Thousand Eight Hundred and Five only)** after reckoning repayments, if any, amounting to Rs. NIL subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

- (1) The property will be sold by e-Auction through the Bank's approved service provider <https://baanknet.com/eauction-psb/bidder-registration> under the supervision of the Authorised Officer of the Bank.
- (2) The intending Bidders/Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using, their mobile number and email-ID further, they are requested to upload requisite KYC documents.
- (3) Bids in the prescribed formats shall be submitted "online" Through the portal <https://baanknet.com/eauction-psb/bidder-registration> along with the EMD & scanned copy of KYC documents including Photo, PAN Card, ADHAAR Card & address proof to the service provider and the Authorised Officer respective branches on or before the date mentioned above for submission of bid.
- (4) The EMD and other deposits shall be remitted through UPI / NET BANKING / NEFT / RTGS to the **wallet provided by PSB Alliance (baanknet)** on its e-auction site

- (5) Bids without EMD shall be rejected summarily.
