Mrs Laxmi Yashwant Pawar availed Term loan facility from Indian Bank, Dombivli West the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mrs Laxmi Yashwant Pawar** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 07.10.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) **Mrs Laxmi Yashwant Pawar** liable to the Bank to pay the amount due to the tune of Rs. **Rs.13,20,980.00/-** (Rupees Thirteen Lakh Twenty Thousand Nine Hundred Eighty Only) as per demand notice dated 07.10.2024 with total amount of Rs 1654193.00 (Rupees Sixteen lakh Fifty Four thousand One hundred ninty three Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 07.10.2024

As **Mrs Laxmi Yashwant Pawar** failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.
