from 12.00 PM to 5.00 PM by inviting Bids from the public through online mode on www.baanknet.com.

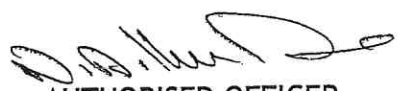
