M/s Jay Baba Jhumraj Agency (Proprietor- Mr. Pankaj Kumar Barnwal), availed Cash Credit facility from Indian Bank, Barakar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Jay Baba Jhumraj Agency (Proprietor- Mr. Pankaj Kumar Barnwal), failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.02.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) liable to the Bank to pay the amount due to the tune of Rs 4183726/- (Rupees Forty one lakhs eighty three thousand seven hundred twenty six only) as

on 18.02.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 21.02.2026.

M/s Jay Baba Jhumraj Agency (Proprietor- Mr.Pankaj Kumar Barnwal) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 13.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.
