12 (a) In case of bidding, the bid increment shall not be less than Rs.25,000- in excess of highest bid amount or the immediate preceding bid, as the case may be with multiple increment value of Rs.25,000/-.

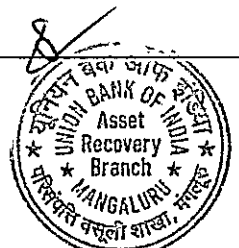
