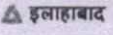

Laxman Batham S/o Nandram Batham availed Housing Loan facility from Indian Bank, Vidisha Branch (erstwhile Allahabad bank), the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Laxman Batham S/o Nandram Batham failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 14/06/2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon the estate of the deceased Late. Dolly Raikbar liable to the Bank to pay the amount due to the tune of **Rs. 6,47,707.00 (Rupees Six Lakh Forty-Seven thousand and Seven Hundred Seven only)** as on 06.06.2024 with further interest, costs, other charges and expenses thereon. But failed to make payment despite Demand Notice dated 14/06/2024.

As the estate of the deceased Late Laxman Batham failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03/10/2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **12.08.2026** is **Rs 9,98,942/- (Rupees Nine Lakhs Ninety-Eight Thousand Nine hundred and forty-two only)** with further interest, costs, other charges and expenses thereon from 13/08/2026.

Please take note that this is **notice of 15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
