M/s Vanshika HDPE Sprinkler & Mini Sprinkler, Prop – Mrs. Chanchal Rajput W/o Mr. Ganesh Pratap Rajput availed All trade facility from Indian Bank, Vidisha Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. M/s Vanshika HDPE Sprinkler & Mini Sprinkler, Prop – Mrs. Chanchal Rajput W/o Mr. Ganesh Pratap Rajput failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower M/s Vanshika HDPE Sprinkler & Mini Sprinkler, Mrs. Chanchal Rajput W/o Mr. Ganesh Pratap Rajput and Mr. Ganesh Pratap Rajput S/o Ravinder Singh Rajput liable to the Bank pay the amount due to the tune of **Rs 55,69,253** (Fifty Fifty Five Lacs Sixty Nine Thousand Two Hundred Fifty Three Only) as on 21.11.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite demand notice dated 21.11.2025.

As M/s Vanshika HDPE Sprinkler & Mini Sprinkler, Mrs. Chanchal Rajput W/o Mr. Ganesh Pratap Rajput and Mr. Ganesh Pratap Rajput S/o Ravinder Singh Rajput failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.02.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 18/08/2026 is **Rs. 6265874/- (Rupees Sixty two lakhs Sixty five Thousand Eight Hundred Seventy four Only)** with further interest, costs, other charges and expenses thereon from 19/08/2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
