Anil Kumar s/o Subhash Chand availed Term Loan from Indian Bank, DELHI CHUNGI MEERUT Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Anil Kumar s/o Subhash Chand** failed to pay the outstanding dues to the Bank.
