Mr.Jeeth Krishnan Anand and Mrs.Nisha Jeeth have availed Home loan facility from Indian Bank, **Koorkenchery** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr.Jeeth Krishnan Anand and Mrs.Nisha Jeeth** failed to pay the outstanding dues to the Bank. Therefore, a **Demand Notice dated 15.02.2024** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **Mr.Jeeth Krishnan Anand and Mrs.Nisha Jeeth** liable to the Bank to pay the amount due to the tune of Rs. 1,12,01,069/- (**Rupees One Crore twelve lakhs one thousand sixty nine Only**) and any other dues/charges to be paid to any Govt. Office/Department as on 14.02.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 15.02.2024.

As **Mr.Jeeth Krishnan Anand and Mrs.Nisha Jeeth** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 19.08.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of subsequent intended sale is required to be given and hence we are issuing this notice.

The amount due as on 02.09.2026 is Rs. 1,45,43,748/- (**Rupees One Crore Forty-five lakhs forty-three thousand seven hundred forty-eight Only**) and any other dues/charges to be paid to any Govt. Office/Department with further interest, costs, other charges and expenses thereon from 03.09.2026.
