SALE NOTICE

(Letter to the Borrower before effecting the sale of repossessed vehicle)

Dear Sir/Madam,

This has reference to our earlier notices dt. 10.11.2025 with respect to your captioned loan accounts. On your failure to repay the dues, the Bank had repossessed the vehicle(TRUCK- Regd No.- OD-19Z-1726,) purchased under the loan amount.

2.
