M/s. MONALI COOL FOOD PROCESSOR availed Term Loan facility from Indian Bank (Parent Branch – Suri Branch, erstwhile Allahabad Bank-), the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Monali Cool Food Processor failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 30.08.2019. under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) /s. Monali Cool Food Processor, Vill Nutun Pally, Vidyasagar College Para Post Suri Ps Suri, Dist Birbhum-731101. 1.Ms Barnali Mahanta, Mortgagor Guarantor Musaroff Hossain, liable to the Bank to pay the amount due to the tune of Rs.45,04,660.00 (Rupees Forty Five Lakh Four Thousand Six Hundred Sixty only) as on 30.08.2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 30.08.2019.

As M/s. M/s. Monali Cool Food Processor failed to make payment despite Demand Notice the Authorized Officer took **constructive possession** of the schedule mentioned properties under the Act on 26.11.2019 and physical possession taken on 27.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of sale is required to be given and hence we are issuing this notice.

The amount due as **Rs. 45,04,660.00 (Rupees Forty Five Lakh Four Thousand Six Hundred Sixty only)** as on **30.08.2019** with further interest, costs, other charges and expenses from thereon.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 09.09.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **03.09.2026** to **08.09.2026** between **11.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
