NOTICE OF INTENDED SALE

Notice of intended sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr. Phool Badan Yadav availed Loan facility from Indian Bank, Civil Lines Prayagraj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Phool Badan Yadav failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.10.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / Guarantor(s) Mr. Phool Badan Yadav liable to the Bank to pay the amount due to the tune of Rs Rs. 24,21,405.00 (Rs Twenty Four Lakh Twenty One Thousand Four Hundred Five only (as on 28.09.2025)) with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.10.2025.

As Mr. Phool Badan Yadav failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 19.02.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 20.08.2026 is Rs. 25,12,824.00 (Rupees Twenty Five Lakh Twelve Thousand Eight hundred Twenty Four only) with further interest, costs, other charges and expenses thereon from 21.08.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.
