1) Mr. Dharaneesh N(Borrower) (2) Mr. Nagaraj R(Co Borrower) 3. Mrs Gayathri Devi N(Co Borrower) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 27.02.2026 after complying with all legal formalities.
