Whereas the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on 17.03.2026 calling upon the Borrowers **M/s R S Enterprises (Prop: Mr. Rajeev Kumar Singh) and Guarantors Mrs. Sunita Singh & Praveen Kumar Agarwal** to repay the amount in terms of the said notice within 60 days from the date of the said notice.

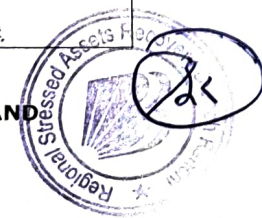
