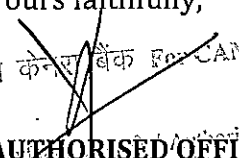

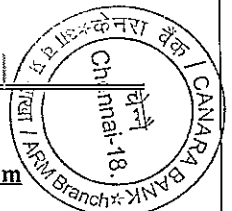

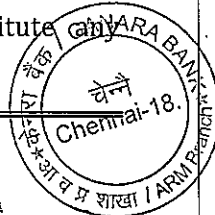

- b. The property/ies will be sold above the reserve price.

- d.
