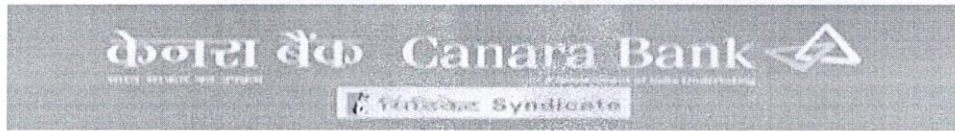

The said loan documents / agreements executed by the borrower entitle the Bank to take physical possession of the movable securities (Vehicle/ P&M/Stock) hypothecated, in the event of default by the borrower & guarantors in repaying the dues as per the terms.

Since the borrower M/s / Mr. /Mrs. SMG FLOAT GLASS WORKS has defaulted in repayment of Bank's dues, the Bank has invoked hypothecation vide Demand Notice dated 19.08.2020. Despite of repeated request / demand by Bank, the borrower has not regularized the account / cleared the Bank's dues. 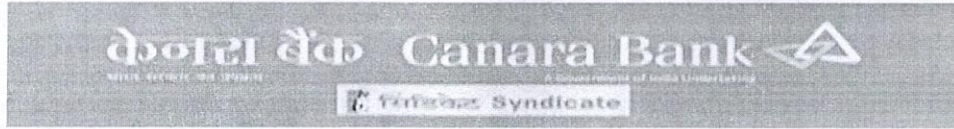

2. The Vehicle/P&M/Stock will be sold in "As is where is", "As is what is", and "Whatever there is" condition, including encumbrances if any. (There are no encumbrances to the knowledge of the Bank. 3. The Vehicle/P&M/Stock will be sold over & above the Reserve Price fixed by the Bank and minimum increment over the reserve price shall be Rs. 5,000/- (Rupees Five Thousand only).
4. 6. Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of Rs. 5,000/- (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1).
