Mr. Vijay Kumar Madhukar Kulkarni, Mr Ravindra Laxman Shegure, Mrs. Namrata Vijaykumar Kulkarni and Mrs. Namrata Vijaykumar Kulkarni availed loan from Indian Bank, Solapur Main Branch in the name Mr. Vijay Kumar Madhukar Kulkarni, Mr Ravindra Laxman Shegure, Mrs. Namrata Vijaykumar Kulkarni and Mrs. Namrata Vijaykumar Kulkarni the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Borrowers".
