Mrs. Ritu Sanjay Talwar availed Housing facility from Indian Bank, Aurangabad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. Mrs. Ritu Sanjay Talwar failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 26/08/2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mrs. Ritu Sanjay Talwar and Sanjay Jagdishchnadra Talwar, Kunal Sanjay Talwar, Sadhu Dhondiba Gawali liable to the Bank to pay the amount due to the tune of **Rs 16,35,809/- (Rupees Sixteen Lakh Thirty Five Thousand Eight Hundred Nine Only)** as on 02/11/2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 26/08/2019.

As Mrs. Ritu Sanjay Talwar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18/01/2020, physical possession taken on 29.08.2026 after complying with all legal formalities.

The amount due as on **31.08.2026** is **Rs. 25,48,544 /- (Rupees Twenty-Five Lakh Forty-Eight Thousand Five Hundred Forty Four Only)** with further interest, costs, other charges and expenses thereon from **01.09.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
