E-AUCTION SALE NOTICE

Whereas, Mr. **BALU VANRAJ JADHAV** has borrowed monies from Indian Overseas Bank, against the mortgage of the immovable properties, more fully described in the schedule hereunder and the Bank has issued a Demand Notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on **06.12.2025**, calling upon the borrower Mr. **BALU VANRAJ JADHAV** to pay the amount due to the Bank, being **Rs.11,93,690.81 (Rupees Eleven lakhs ninety three thousand six hundred ninety and paise eighty one only)**, as on **06.12.2025** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

The dues to the bank as on the date of taking possession was intimated **Rs.12,13,644.81 (Rupees Twelve lakhs thirteen thousand six hundred forty four and paise eighty one only)**, as on **11.02.2026** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **03.09.2026** works out to **Rs.12,87,197.81 (Rupees Twelve lakhs eighty seven thousand one hundred ninety seven and paise eighty one only)**, after reckoning repayments, if any, subsequent to the Bank issuing demand notice.

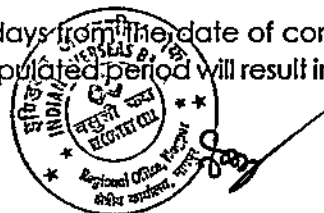

Terms and conditions of E-auction

1. The property(ies) will be sold by e-auction through the service provider <https://www.psballiance> under the supervision of the of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://BAANKNET.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **24.09.2026** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <https://BAANKNET.com> which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. 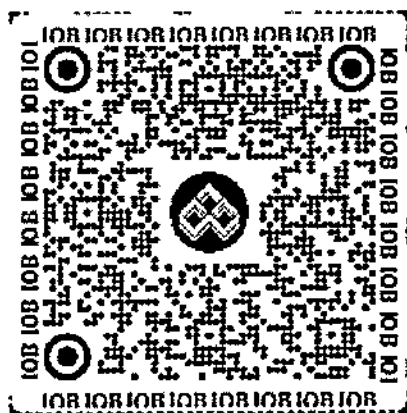
