- b. The property/ies will be sold above the Reserve Price.

- d. The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs. 151300 (Rupees One Lakh Fifty one Thousand three hundred Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **25-09-2026** at 5.00 PM.
- f. Auction would commence at Reserve Price, as mentioned above.
