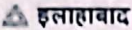

Notice of sale under Rule 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

M/S Gayatri Corporation availed Cash Credit facility from **Indian Bank Civil Lines Shahjahanpur Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Gayatri Corporation failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) mentioned above liable to the Bank to pay the amount due to the tune of **Rs.35,90,184 /-(Rupees Thirty Five Lakh Ninety Thousands One Hundred eighty four Only)** as on 17.11.2025, with further interest, costs, other charges and expenses thereon. You have failed to make payment despite Demand Notice dated 17.11.2025.

As M/s Gayatri Corporation failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 20.05.2026 after complying with all legal formalities. As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30days' notice of intended sale is required to be given and hence we are issuing this notice. The amount due as on 17.11.2025 is of **Rs.35, 90,184 /- (Rupees Thirty Five Lakh Ninety Thousands One Hundred eighty four Only)** with further interest, costs, other charges and expenses.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30days.

The date of sale is fixed as 21.09.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 13.08.2026 to 19.09.2026 between 10.00 am to 4.00 pm.
