M/s Minnus Restaurant availed the above loan facilities from Indian Bank, Chengamanad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. M/s Minnus Restaurant failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 11.05.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s) M/s Minnus Restaurant, Guarantor(s)/ Mortgagor Mr Abdul Jabbar liable to the Bank to pay the amount due to the tune of Rs. 11,98,362/- (Rupees Eleven Lakh Ninety-Eight Thousand Three Hundred and Sixty-Two only) on 10.05.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 11.05.2026.

As M/s Minnus Restaurant failed to make payment despite Demand Notice dated 11.05.2026, the Authorized Officer took possession of the schedule mentioned properties on 29.07.2026 under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
