Mr. Dino Jacob (Borrower and Mortgager), Mrs. Mary Chacku (Co-Borrower & Mortgagor) and Mr. Rino Jacob (Guarantor & Mortgagor) availed Education loan facility from Indian Bank, Angamaly Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties" **Mr. Dino Jacob (Borrower and Mortgagor), Mrs. Mary Chacku (Co-Borrower & Mortgagor) and Mr. Rino Jacob (Guarantor & Mortgagor)** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20.05.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **Mr. Dino Jacob, Mrs. Mary Chacku and Mr. Rino Jacob** liable to the Bank to pay the amount due to the tune

of Rs. 11,30,929/- (Rupees Eleven lakhs thirty thousand Nine hundred and twenty nine only) as on 19.05.2026 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 20.05.2026.

As **Mr. Dino Jacob, Mrs. Mary Chacku and Mr. Rino Jacob** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 04.08.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **01.09.2026** is **Rs. 11,80,941/- (Rupees Eleven lakhs eighty thousand Nine hundred and fourty one only)** with further interest, costs, other charges and expenses thereon from 02.09.2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 07.10.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **03.09.2026** to **06.10.2026** between **10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/ cancel the sale without assigning any reason therefor.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer. 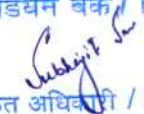
