As Mr. Swapan Nath (Debnath) (Borrower/ Mortgagor), S/o- Jadab Nath (Debnath) Vill- Purba Dighirpar Mazar Para, P.O- Dighirpar P.S. Canning-1 Dist-South 24Parganas Pin-743329 failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act on 17.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
