Mr K Manoj s/o Mr Kesavan and Mrs Dhanya Manoj w/o Mr K Manoj availed Housing loan facility from Allahabad Bank, Kottayam Branch (now amalgamated with Indian Bank) the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr K Manoj s/o Mr Kesavan and Mrs Dhanya Manoj w/o Mr K Manoj failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 08.11.2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Mr K Manoj s/o Mr Kesavan and Mrs Dhanya Manoj w/o Mr K Manoj liable to the Bank to pay the amount due to the tune of **Rs.26,17,763/- (Rupees Twenty six lakhs seventeen thousand seven hundred and sixty three only)** as on 07.11.2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 08.11.2019

As Mr K Manoj s/o Mr Kesavan and Mrs Dhanya Manoj w/o Mr K Manoj failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 15.02.2020 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:





THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 23.08.2026 is **Rs.52,26,278/- (Rupees Fifty two lakhs twenty six thousand two hundred and seventy eight only)** with further interest, costs, other charges and expenses thereon from 24.08.2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 29.09.2026 which would be by e-auction mode.

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 28.09.2026 i.e the e-Auction Date and before the e-auction end time in the portal.
