Smt. Srividya Rajesh and Shri. S. Rajesh Mahalingam availed loan facility from Indian Bank, Kotturpuram Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Smt. Srividya Rajesh and Shri. S. Rajesh Mahalingam** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **23.01.2015** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling **Smt. Srividya Rajesh and Shri. S. Rajesh Mahalingam** to pay the amount due to bank to the tune of **Rs.55,43,449/- (Rupees Fifty five lakhs forty three thousand four hundred and forty nine only)** (as on **23.01.2015**) with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **23.01.2015**.

As **Smt. Srividya Rajesh and Shri. S. Rajesh Mahalingam** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **29.05.2015** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **31.08.2026** is **Rs.1,70,85,251/- (Rupees One crore seventy lakhs eighty-five thousand two hundred and fifty-one only)** with further interest, costs, other charges and expenses thereon from **01.09.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **17.09.2026 to 18.09.2026 between 10.00 am and 4.00 pm.**

The intending Bidders/Purchasers are requested to register with online portal (<https://www.baanknet.com>) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.
