M/S The Book Society (Prop: Mr. Kazi Sad Salim) availed credit Facility/ies from Indian Bank, Dharamtolla Branch, Kolkata, the repayment of which is secured by Mortgage /creation of security interest of schedule mentioned properties hereinafter referred to as "the Properties". **The Book Society (Prop: Mr. Kazi Sad Salim)** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 22.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), **The Book Society, Prop Mr.Kazi Sad Salim**, Guarantor being the borrower/ Guarantor *liable* to the Bank to pay the amount due to the tune to **Rs.25,95,094.00 (Rupees Twenty Five Lakh Ninety Five Thousand –Ninety Four Only** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 22.04.2026

As The Book Society Prop Mr. Kazi Sad Salim being the Borrower / Guarantor/Mortgagor failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 10/07/2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 29.07.2026 is **Rs. 26,79,311.00 (Rupees Twenty-Six Lakh Seventy-Nine Thousand Three Hundred and Eleven only)** plus interest, cost & charges w.e.f 30.07.2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 09.09.2026 which would be by e-auction mode.

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/ Purchasers

have to transfer the EMD amount in his Global EMD Wallet before the e-Auction Date and time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.
