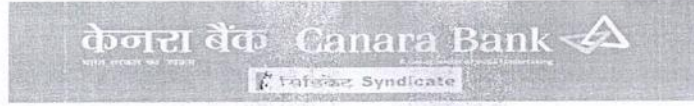

- f) Auction would commence at Reserve Price, as mentioned above.
