13	Other conditions	(a) The Bidders should get themselves registered on https://baanknet.com/ by providing requisite KYC documents and registration fee as per the practice followed by PSB Alliance Pvt Ltd well before the auction date. The registration process takes minimum of two working days. (Registration process is detailed on the above website). (b) Haryana State Property ID (PID) is not available with Bank. The intending bidder should verify the ID in Revenue record / relevant Revenue portal to avoid any difficulty at the time of registration of property. (c) The property is being put on e-auction on symbolic possession basis. The physical possession of the property may take time. There may be inordinate delay in the same as it depends on revenue authorities and subject to other future litigations that may arise. The successful bidder will not claim any interest for delayed physical possession nor initiate any action against Bank/ its officials for delay in physical possession, if any. (d) The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with PSB Alliance Pvt Ltd at https://baanknet.com/ by means of NEFT/ RTGS transfer from his bank account. (e) The Intending bidder should take care that the EMD is transferred and confirm that his wallet maintained with PSB Alliance Pvt Ltd is reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
