E-Auction Sale Notice

P V RAM KRISHNA RAO)** , ii) **Mrs. P SAVITRI(GUARANTOR) W/O P.V RAM KRISHNA RAO** iii) **Mr. P BRIJESH KUMAR S/O P V RAM KRISHNA RAO** ,have borrowed monies from Indian Overseas Bank against the mortgage of the immovable property more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a **Demand Notice** to the Borrowers under Section 13(2) of the SARFAESI Act, 2002 (Act) on **30.12.2023** calling upon the borrowers i)) **M/s Anand Enterprises (Prop. Whereas the borrower having failed to pay the amount dues in full to the bank as called for in the said demand notice, the bank has taken possession of the secured assets more fully described in the schedule hereunder on 09.04.2024 under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8&9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.65,37,552/- (Rupees Sixty-Five Lakhs Thirty-Seven Thousand Five Hundred Fifty-Two only) as on 09.04.2024** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

2. The intending Bidders /Purchasers are requested to register on portal **URL: <https://baanknet.com/eauction-psb/bidder-registration>** using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to transfer the EMD amount using online mode in their Global EMD Wallet account by **24.09.2026 before 02.45 P.M** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3.
